# City Floral Photography

## Guidelines & Policies

Thank you for choosing City Floral Garden Center for the backdrop of your photography project! We require that you purchase a permit and follow our policies to ensure safety of our plants, customers, staff, and your group.

We encourage your use of our social media tags: #cityfloralgardencenter #cityfloraldenver; and @cityfloral.

### Why a permit?

Permits allow us to plan for your photography group to be in the garden center on the day and time you've requested. It also helps ensure that you will have the least amount of distraction or interruptions or chance of cancellation.

### Who needs a permit?

A permit is required for all organized photo & video shoots, including but not limited to: wedding, engagement, graduations, and birth announcements.

#### OUR POLICIES

- **You will need a permit regardless of whether you are a professional photographer or not**
- **We do not allow stock photography**
- **Your group is limited to 12 people, including the photography crew**
- **A permit grants two hours of time in the garden center. To extend that time, an additional permit must be purchased**
- **Service animals are permitted, no other animals are allowed**
- **Sessions must occur during normal business hours**
- **Subjects to be photographed must be dressed appropriately for a public place of business and be ready on arrival. No breakrooms or bathrooms will be provided.**

#### POLICIES continued

- **Plants and other store items must not be moved or disturbed**
- **Climbing or stepping into or onto displays or plant beds is prohibited**
- **Climbing trees, fences, or other structures on the premises is prohibited**
- **Sessions must not disrupt customers or interfere with the garden center staff**
- **Permits must be purchased at least 2 weeks before the requested day**
- **Permit fees will be refunded, if photo shoot is cancelled a minimum of 7 days prior to the scheduled/approved date**
- **NO PHOTOGRAPHY PERMITS WILL BE ISSUED FOR SHOOT DATES BETWEEN APRIL 1ST AND JUNE 30TH. SOME WEEKEND DATES ARE ALSO RESTRICTED**

City Floral is not responsible for the loss, theft, or damage to any equipment or property belonging to you or anyone in your group.

City Floral reserves the right to cancel or end a photography session if it is apparent that the policies are not being followed, without refund of permit.

City Floral employees may approach photographers at any time to request to see the permit. City Floral may approach to relocate you or discuss alternatives in the event of maintenance, business operations, etc.

City Floral reserves the right to turn away photographers at our discretion, without explanation.
